This plant is the last recipient of plastics waste and produces products.

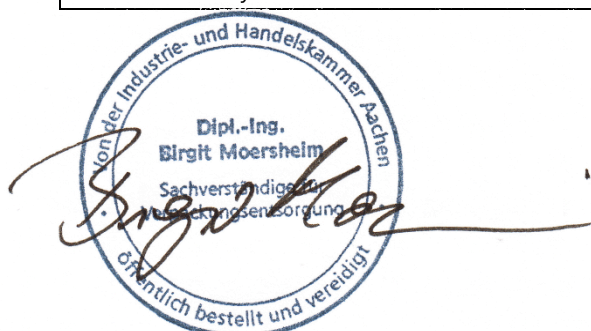
